For Jammu Division:

Hard Copy of the Application Form either by hand, post or courier shall not be accepted after the last date.

The Selected Candidate shall have to submit the migration certificate (if required) within 20 days from the date of admission. The Selected Candidates have to go for contact classes and examination and other components of the programme

Those Candidates failing in B.G 2nd Year (Environmental Science) are not eligible to apply.

- The Candidates who have completed their degrees through Study Centres which are located outside the territorial jurisdiction
- of their respective recognized Universities are not eligible to admission except MANNU, IGNOU & DOEACC.

 Candidate whose form is displayed as Verified but not deposit the fee of Rs 250/- on the auto-generated fee slip.
