**Payment of Dearness Allowance to UHBVNL Employees on revised scale of pay w.e.f. 01.01.2013.**

The UHBVN is pleased to adopt the Haryana Government, Finance Department order no. 4/1/2009-5 FR/12166 dated 03.05.2013 regarding enhancement of dearness allowance from 72% to 80% w.e.f. 1<sup>st</sup> January 2013 to its employees in the revised pay scales as per terms & conditions given below:-

1. The additional installment of dearness allowance payable under these orders shall be paid in cash to all the State Govt. employees for the month of May 2013 paid in June 2013.
2. The payment of arrear of enhanced dearness allowance for the month from January 2013 to April 2013 shall be made in the month of June 2013.

The above enhanced rate of Dearness Allowance will not be applicable to the Daily Wage workers in the Nigam.

The above order of the State Govt. has been adopted in UHBVN in pursuance of decision of Whole Time Directors of UHBVNL, Panchkula.

**Subject:-** Payment of Dearness Allowance to Haryana Government employees in the revised pay scales from 01.01.2013.

Sir/Madam,

I am directed to refer to Finance Department letter No.4/1/2009-5FR/8659, dated 10<sup>th</sup> October, 2012 on the subject noted above and to say that the Governor of Haryana is pleased to decide that the Dearness Allowance payable to Haryana Government employees shall be enhanced from the existing rates of 72% to 80% of the pay w.e.f. 1<sup>st</sup> January, 2013.

2. The additional instalment of Dearness Allowance payable under these orders shall be paid in cash to all Haryana Government employees for the month of May, 2013 paid in June, 2013.

3. The payment of arrear of enhanced Dearness Allowance for the month from January, 2013 to April, 2013 shall be made in the month of June, 2013.
