CORRIGENDUM OF EMPLOYMENT NOTICE

The name of the post should be read as 'Pharmacist(T)' In T&S Gr.'C'.	10+2 with science /Diploma in Pharmacy registered with Pharmacy Council under Pharmacy Act.1948 with valid registration. The Diploma in Pharmacy referred to above should be recognized/approved by the Pharmacy Council/ Central/State .

Note:-In earlier notification the minimum qualification was Matriculation plus Diploma in Pharmacy from recognized Institute /approved by the Government plus 2(two) years practical training. However, qualification/eligibility criteria has been modified as 10+2 with science in place of matriculation and condition of 2 (Two) years practical training has been deleted. Hence, now the candidates having 10+2 with science and Diploma in pharmacy registered with Pharmacy Council under Pharmacy Act.1948 with valid registration will only be eligible.

Hospital. In the modified eligibility criteria the matriculation and condition of 3(Three) years experience has been deleted . Hence, candidates having only Diploma in respective technology from an institute recognized by Govt. are eligible for said post.
