INSTRUCTIONS/ PROCEDURE FOR CANDIDATES WHO HAVE PARTICIPATED IN THE FIRST AND SECOND ROUND OF COUNSELLING IN PROGRAMME B.TECH/ M.TECH (DUAL DEGREE) & B.TECH PROGRAMMES (CET CODE: 131)

PROCEDURE FOR 3RD ROUND OF COUNSELLING

The result for first round of counselling was displayed on 23rd July, 2013. The result for second round of counselling was displayed on 01st Aug 2013.

In the second round of counselling, the candidates were allotted seats for the Programme B. Tech in accordance with their preference / choice.

Those who were allotted seat in the colleges/ Institute were required to deposit the fee of Rs 40, 000/- upto the last date, 07th Aug, 2013.

The candidates who have participated in the second round of counselling and have been allotted any college/ Institute but have failed to deposit the Fee of Rs 40,000/- upto the last date 07th Aug, 2013 will not be allowed to participate in the 3rd round of counselling.

The participating candidates can be categorised in the following cases.

S. No.	Category of candidates	Action to be taken
1	Those candidates who have qualified CET and had generated challan of Rs.1000/- and deposited in designated branch, but did not fill choices/ preferences till date	The candidates can log-in to their respective account and can fill choices/ preferences on 10 th & 11 th Aug, 2013, and wait for allotment of seats in the 3 rd round of counselling.
2	Those candidates who have qualified CET and had filled choices/preferences, and have been allotted college/ institute of their first choice/preference and are now satisfied and do not wish to change their choice/preference.	They are now required to report to their respective college/ Institute and they are not required to modify /change their preference and the institute/college allotted as the first preference will be retained and treated as freezed.
3	a) Those candidates who have qualified CET and had filled choices/preferences, and have been allotted college/ institute of second or other lower choices/	a) The candidates who are satisfied with their preference/choice may log-in to their respective account and modify by deleting all other preferences/ choices. The

	preferences and the candidates are now satisfied with the allotment of college/ branch and do not wish to change their preference/ choice.	candidates must keep only the allotted college/branch as their only preference/choice. If the candidates do not do so, they may be further upgraded to other preferences/choices and the University will not be held responsible for the consequences and if any college/ branch is allotted in the 3 rd round it will be treated as final.
	b) Those candidates who have qualified CET and had filled choices/preferences, and have been allotted college/ institute of second or other lower choices/ preferences and the candidates are not satisfied with their second or other lower choices/ preferences and further wish to get upgraded to other choices/preferences.	b) The candidates can log -in to their account and update/modify the choices/preferences on 10 th & 11 th Aug, 2013, and wait for further upgradation/allotment of seats in the 3 rd round of counselling.
4.	Those candidates who have qualified CET and had filled choices/preferences of college/Institute, but have not been allotted any college/Institute of their choice/preference.	The candidates can further update/modify the choices/ preferences on 10 th & 11 th Aug, 2013, and wait for the 3 rd round of counselling for allotment of seats.

Please note that for the 3rd Round of Counselling, the candidates can now log-in to their account and modify and update the choices/preferences on 10th & 11th Aug, 2013, for the 3rd Round of Counselling.

The result for allotment of seats for the 3rd round of counselling is likely to be declared on 13th Aug, 2013.
