# Go ahead with arrests, don't take any influence: HC tells CB

Srinagar, July 2: Jammu and Kashmir High Court has directed Inspector General of Police, Crime Branch, to exercise overall supervision in the probe of CET scam so that any extraneous influence in execution of arrest warrants against 15 accused still at large is effectively checked.

The direction came after the court observed that the accused must be wielding influence and would be approaching power echelons to evade their arrest.

"However, apart from property attachment, no other mechanism has been used. Why it has happened cannot be left to the imagination because it appears that out of 51, the 15 who are still at large must be wielding some type of influence," a division bench of Chief Justice M M Kumar and Justice Hasnain Massodi said in its order.

Accepting the suggestion of Amicus Curie Bashir Ahmad Bashir that to cut short the time stretch to arrest the absconders and to steer the probe clear of any external influence, IG Crime should oversee the investigation, the division bench sought progress report

threshold." the division bench observed. The court urged the investigating agency and police to act diligently to cleanse the society of elements responsible for spoiling the careers of diligent students.

Disagreeing with the CB over its approach to attach the properties of the accused who did not surrender so far, the division bench said, "When, as sample, we examine the attachment order of the property pertaining to Mushtaq Ahmad Kenu, the attachment order shows that some land belonging to Kenu has been attached. He is a known businessman and nothing has been pointed out with regard to his business concern or his bank account. We presume that similar situation must

be prevailing in other cases. It said, "On the last hearing we have passed detailed directions, bringing to the notice of investigating officers various mechanism available in Criminal Procedure Code which could have been used for ensuring the arrest of any

Citing the status report by CB pointing out that in respect to the investigation of CET-2010 scam some evidence was found and for 2009 and 2011 the agency was to close the investigation for lack of evidence, the division bench said, "We are unable to appreciate how investigation in respect of admission made with respect to 2011 could be closed when the evidence is readily available in respect to

admission made in year 2010." However, after Advocate General, M I Qadri, submitted that some more time be given to the investigating agency to collect evidence in respect of year 2009. 2010 and 2011, the court sought a fresh report before the next date of hearing.

The division bench directed cellular companies - BSNL, Vodafone, Airtel, Aircel-to cooperate by furnishing information required by the investigating officer.

Following the observation that particulars of four more candidates have been sent to BOPEE for action after they have been found to have benefitted by acquiring CET papers in advance, counsel for BOPEE, G A Lone, pointed out that the admission in respect of 25 beneficiary candidates has already been cancelled and list of four is still under consideration of BOPEE. "The status report with regard to four beneficiaries be filed within two weeks," the division bench said.

The court also allowed submission by Advocate General regarding filing of status report on disciplinary action against government employees who have been found involved in the fraud.
