Whereas, the Common Entrance Test in 2012, for short CET, was conducted on 23rd and 24th of June 2012 by Board of Professional Entrance Examinations, for short BOPEE, for selection of candidates for admission to MBBS, BDS, BE-Engineering, BVSc, B.Sc.Agriculture, BAMS, BUMS Courses in Govt. and Private Professional Colleges/Institutions;

Whereas, the result of said CET was declared on 29.06.2012 and selection on the basis of inter-se-merit of candidates rank-wise was notified vide Notification No: 34-BOPEE of 2012 dated: 29.06.2012;

Whereas, you had applied and appeared in CET Examination of 2012 and were selected for admission to MBBS Course in Govt. Medical College, Srinagar and pursuant to said selection and admission you are pursuing the said Course at present;

Whereas, the Hon’ble J&K High Court at Srinagar took suomoto action in respect of alleged malpractice in the conduct of aforesaid examination, widely published by the local press which led to registration of Public Interest Litigation bearing PIL No: 15/2013 titled Court on its motion versus State and others and directions to the Crime Branch, Kashmir to investigate alleged malpractice in CET 2012 conducted by BOPEE;

Whereas, the Crime Branch registered FIR No: 24/2013 under section 420, 120-B, RPC 5(2) PC Act, against the then Chairman of BOPEE Shri Mushtaq Ahmad Peer for his nefarious activities in the conduct of examination;

Whereas, the Hon’ble High Court vide its order dated: 03.02.2014 directed the Crime Branch to communicate to the concerned authorities, including BOPEE, about the development of the investigation of the case to enable them to take appropriate action as permissible under applicable rules;

Whereas, the Crime Branch vide letter Nos: CHQ/FIR-24/13/CBK-7665 dated 26-06-2014 reported that you have managed your selection for undertaking MBBS Course and figured in the selection list of 2012 on the basis of illegal and fraudulent means by obtaining access to question papers in advance on payment of illegal gratification;

Whereas, the Crime Branch has recommended vide letter Nos: CHQ/FIR-24/13/CBK-7665 dated 26-06-2014 to the BOPEE to take appropriate action against you as permissible under applicable rules;

Now before taking any action, which may even include cancellation of your admission for undertaking the course, you are provided an opportunity to explain your position in writing and signed in this regard within seven days from the date of publication of this notice, failing which it shall be presumed that you have nothing to say in this matter.
