Whereas, among others, Shri Ishrat Hussain Thoker S/O Abdul Ahad Thoker R/O Gudoora tehsil and district Pulwama came to be provisionally selected under Open category for the post of ASI(Steno) Vide PHQ order Nc.505 of 2013 dated 21.02.2013;

Whereas, above named candidate, among others, was asked through the medium of call letter/concerned Police Station to report in the PHQ J&K within a period of 21 days alongwith original testimonials for completing the pre-appointment formalities and other conditions required under rules, which he failed to do;

Whereas, vide PHQ signal No: Estt/R-04/2010/13141 dated 16.03.2013 and No: Estt/R-04/2010/2242 dated 14.05.2013, the said candidate was informed through Police Station Pulwama to report'at PHQ but he failed to respond to these notices. Subsequently, a notice was also got published in the local dailies on July 6th /7th, 2013 asking the candidate to report at PHQ within a week's time positively for fulfilling the requisite pre-appointment formalities;

Whereas, vide letter No: Estt/M-4/14/10022 dated 18.06.2014 SP Pulwama has forwarded written unwillingness from the said candidate wherein he has asserted that he was not interested in joining the Police Department as ASI(S) and requested for cancellation of his selection, ordered as such vide PHQ order No. 505 of 2013 dated 21.02.2013;

Whereas, notwithstanding repeated opportunities afforded to the said candidate, he has failed to join the Police Department and ultimately declined to join the Police Department as ASI(S).

Therefore, for the reasons as recorded above and in light of the facts above, selection in respect of Shri Ishrat Hussain Thoker S/O Abdul Ahad Thoker R/O Gudoora tehsil and district Pulwama as ASI(S) ordered vide PHQ order No 505 of 2013 dated 21.02.2013 is hereby cancelled abinitio.
