18000 Resonance students pass JEE (Main) **GK NEWS NETWORK**

Srinagar, July 13: In the recently declared merit list of JEE (Main) 2014, as many as 18069 students (Classroom: 13025, Distance Learning: 5044) from Resonance have been declared successful.

In the top-100 all India ranks of general category, six students have secured positions and out of these six, two students are from regular classroom and four from distance learning programs, the institute in a statement said.

In top-200 of General Category 18 students have been declared successful (9 each from classroom and distance learning programs); in top-500 ranks 45 students (22 from classroom and 23 from distance learning programs) and in top-1000 ranks 97 students (47 from classroom and 50 from distance learning programs) have secured positions.

Last year in JEE (Main) 2013 a total of 15240 students were declared successful from Resonance which was highest number of selections in the country from any single institute.
