PCB targeting Kashmir tourism industry only: KEA

Closure of hotels at peak season aimed to destroy Kashmir tourism: KHARA

Srinagar, July 16: The Kashmir Economic Alliance (KEA) led by Farooq Dar and Kashmir Hotels and Restaurant Association (KHARA) today came down heavily on the State Pollution Control Board accusing it of targeting Kashmir hotel industry only.

The two organizations termed the sealing of hotels by the PCB in Lal Chowk here as an attempt to "damage the tourism industry of Kashmir.

The PCB Tuesday sealed five hotels in Lal Chowk here for failing to install Sewerage Treatment Plants (STPs).

Farooq Dar said that cabinet decision on STPs wherein the government has agreed to install

President KHARA Showkat Chowdhary said the state government by virtue of cabinet decision read with order no. 221-FST of 2014 "had clearly directed the PCB not to seal any hotel constructed before 2010.'

said that the hotels would be connected with the common STPs to be constructed by it. However, despite such clear orders the PCB has embarked on an exercise to close the hotels," Chowdhary explained.

The KHARA President said in another government order issued vide SRO no. 475 TSM Ad hoc Chairman KEA of 2013 dated 29-11-2013 the government has decided to set up common STPs for wastewater generated from the hotels

"It is not possible for the hoteliers in Lal Chowk to construct STPs. In Lal Chowk, government doesn't even have a space to build lavatory points. How can then the hoteliers in the area construct separate STPs. The hotels have been constructed decades ago, when there were no such guidelines,'

Chowdhary said. The hotel association also flayed PCB for "only imposing laws in Kashmir region and leaving out Jammu, Katra and Ladakh where tourist inflow is much higher than Kashmir."

"PCB is implementing decisions in Jammu region only verbally but in Srinagar it acts and ensures sealing of the hotels. This clearly speaks of double

standard and a move aimed at hampering tourism season,"

Chowhdary said. Dar alleged that Jammu region has always been favored while Kashmir has been ignored. "From the allocation of funds to implementing ban on hotels, Kashmir has always been sidelined."

He said Jammu region gets more pilgrim tourists and its hotels should have been sealed first "but law has been enforced. in Kashmir only and Jammu, Katra have been spared"

Meanwhile, both KHARA and KEA have appealed the government to construct the STPs quickly "which will help resolve this issue.'

Govt reduces import tariff on gold

Tomato prices shoot up to ₹60 per kg

New Delhi, July 16: As consumers wait for onion prices to cool down, retail prices of tomatoes have skyrocketed to Rs 60 per kg in the national capital.

Mother Dairy's Safal outlets are selling tomatoes at Rs 44 per kg, double of Rs 20 per kg at which the staple was being sold a fortnight ago, while the local vendors are selling it for Rs 50-60 per kg depending upon the quality.

According to traders at Azadpur Mandi, tomato prices in the wholesale market have risen to Rs 30 per kg from Rs 10 per kg at the start of this month.

"Supplies of tomatoes are under stress as the crop from nearby areas in Haryana have exhausted. Currently the supplies are coming mainly from Naryangaon in Maharashtra," Mother Dairy's Fruit and Vegetable Business Head Pradipta Sahoo told PTI.


