

JKEDA tender for solar lights comes under question

Srinagar, July 20: The tender issued by Jammu & Kashmir Energy Development Agency for 47000 solar items has come under question with bidders accusing the agency of subverting the competition.

A group of bidders told Greater Kashmir on Sunday that in June, JKEDA issued tenders for procurement of 47000 solar items. "Two corrigenda were issued in June itself to remove some discrepancies as well as to enhance the scope for more companies to participate in the bid-

ding," they said.
They alleged that the agency though another corrigendum implemented the guidelines of the Central competition."How can they implement CVC guidelines in JK when the body has no jurisdiction here? These guidelines were even twisted to subvert the competition," they alleged, adding that even the "CVC guidelines call for wide participation in bidding to ensure healthy competition."

According to them, the Central Electronics Limited (CEL), a Government of India enterprise, too has raised a letter (CEL/SPV/-M/JAKEDA/ 1607-2014) the CEL has conveyed to the State government that "even the CVC guidelines issued from time to time always have a basic underlying theme that all the prequalification criteria fixed should not contravene the philosophy of fair play and wide competition".

"The corrigendum seems to have been issued without understanding the dynamics of the solar market nascent stage and probably there would be hardly any company which could match the pre-qualification set," the letter said.

Srinagar, July 20: Kashmir Economic Alliance led by Muhammad Yaseen Khan Sunday accused the BJP-led NDA government of adopting discriminative approach against Kashmir to

weaken its economy Chairman, KEA, Muhammad Yaseen Khan said the BJP-led NDA government is working on an "agenda" aimed at "regional disintegration" of Jammu and Kashmir.

"They (BJP) are trying to divide the state on regional lines. An example of which can be had from the discriminatory treatment meted out to Kashmir in the union budget," he said.

Khan said the NDA-government on the very first day of its taking over the reins of the power at New Delhi, raked up the controversy of abrogation of Article 370.

Jitendra Singh, Union Minister of state for Department of Personnel and Training (DoPT), in NDA government had earlier said Article 370 is not in the interest of people and had done "more harm to the state than good."

"If KEA is given 16 votes even for its district presidents and other members, the other trade bodies including hotel associations, Its chief spokesperson, M Y Chapari in a contractors' body, transporters and others are also having their district bodies and chapters in every part of the Valley," it said.

It alleged that KTMF is trying to hijack the popularity of KEA by associating Panchs and Sarpanchs with this alliance.

"KEA after its formation in 2010 had failed to hold elections for past three-and-half years and also failed to draft its constitution. When the EC members smelled the conspiracy for using it for political gains, we opposed it," it said.

"Nine of the 12 constituent bodies have chosen unanimously Faroog Ahamd Dar as its ad hoc chairman and formed three member committee for the elections for which the dates have also been announced," it said.

Srinagar, July 20: Chairman, KEA, Muhammad Yaseen Khan said Kashmir Economic Alliance (led by him) is an apolitical organizing and Panchs and Sarpanchs are neither its members nor associated to it.

Referring to the "controversial" conference at SK Park organized by KEA last month in which Sarpanchs and Panchs had also participated, Khan said it was held "to show our support and solidarity with them." "These elected grass roots representatives have neither joined KEA nor are they part of it," Khan cleared.

Responding to a query about the breakaway faction of KEA, he said: "We have 30 executive members and majority of them are with us. There is no question of breakaway faction, KEA is one and will remain so. Further, if anybody wants to come back to our fold we will welcome them."

Chief Spokesperson, KEA, Siraj Ahmad said: "Some of the disgruntled elements who have recently been terminated from their basic membership are trying to malign the image of the alliance for their vested interests. We would like to make it clear that Sarpanchs or Panchs are not at all part of the KEA, therefore there is no question that KEA has any political or any hidden agenda. Srinagar, July 20: Financial Commissioner, Industries and Comreviewed the implementation of government of India schemes for food processing in Jammu and Kashmir.

The meeting reviewed the projects relating to setting up of abattoirs upgradation of meat shops, fruit collection centres and food processing units. The meeting noted the status regarding the abattoir at Srinagar. Secretary Housing & Urban Development and Director Horticulture informed the meeting that they had received several applications for Modernization of Meat Shops in response to the advertisement through print media by Mission Directorate

MD SIDCO, intimated that the meat shops are eligible for financial assistance up to Rs 5 lakh for modernization, it said. The Financial Commissioner directed that the applications received should be forwarded to the Mission Directorate (J&K SIDCO) so that they could be examined and placed in the next meeting of SLEC for approval.

He directed the Mission Directorate to utilize all the funds at the earliest so that further funds could be received from GOI.
