'The more is aimed at streaming system of setting up vendors and hawkers in specified zones so that they do not become source of traffic hazard or pedestrian discomfort.

"It will also help keep a check on any mushrooming of hawkers or illegal attempts to set up kiosks in the Town Handwara , the Municipal Committee Handwara will strictly follow the National Policy to bring hawkers and vendors on the Market map of Handwara Town with no disturbance to .Town's balance by creating specified zones"
