

Separatists denounce Kousar Nag Yatra

Say pilgrimage politically motivated to divide people

Srinagar, Aug 1: Various separatist leaders and organizations, while denouncing the government decision to declare Kousar Nag as Yatra destination, have condemned the use of 'indiscriminate' force by police and paramilitary forces against people of Kulgam and Shopian, peacefully protesting against the government decision.

Condemning the decision, JKLF chairman Muhammad Yasin Malik, currently lodged in Police Station Kothi Bagh here, said the government of India was destabilizing the already fragile ecology of Jammu Kashmir through religious aggres-

"The new controversy created about Kousar Nag is a conspiracy to divide people of Jammu Kashmir in the name of so-called religious journeys and Yatras," a Front spokesman in a statement quoted

Yasin Malik as having said today. "These new Yatras are not only politically motivated but will have a disastrous effect on already deteriorating ecology of Kashmir also,' said Malik

Yasin Malik said these 'religious aggressions' need strong resistance and JKLF has decided to support all the programs of "Kousar Nag Bachaw Campaign" started by the people of the area.

Expressing concern over desig-

nating Kousar Nag as a new Yatra destination, the Hurrivat Conference (M) today said the government by doing so has acted in haste to please Hindu extremist elements to gain their sympathies.

"The amalgam has always been strong advocate of communal harmony and pleading for the return of Kashmiri Pandits. There are some powerful non-state communal elements who want to spoil the centuries old communal harmony of Kashmir. All this is being done in a systematic way to undermine the Muslim majority character of Jammu and Kashmir which can ieopardize the communal harmony of the region besides changing the distinct culture and identity of Kashmir," a spokesman of the Hur-

riyat said in a statement today. Jammu and Kashmir High Court Bar Association (HCBA) while condemning the decision said, "It is going to destroy the ecology and environment of the area and deprive the people of water for drinking and other purposes.'

"The Bar Association strongly believes that ever since Narendra Modi has become the Prime Minister of India, the Hindu fanatics have joined their hands and started imposing themselves physically, culturally and otherwise on the people of Kashmir so that they are

forced to give up their legitimate demand of right of self-determination and live a life of subjugation," said a Bar spokesman in a state-

ment. The Hurriyat Conference Jammu Kashmir (HCJK) senior leader and National Front chairman Nayeem Ahmad Khan has asked the state government to explain as to how it permitted the 'so called' Kousar Nag and Machil Hindu Yatras.

"How the state government allowed the so called Kousar Nag and Machil Hindu Yatras knowing that these are against the fragile environment and a threat to the identity of the majority people of Kashmir," Nayeem Khan said in a statement today.

Khan has appealed to the Hindu scholars to follow the footprints of Swami Agnivesh and come out openly against the so-called Yatras like Kousar Nag and Machil, which are only aimed at strengthening New Delhi's 'forcible control' on Kashmir.

Meanwhile, the Hurriyat (M) senior leaders including Zaffar Akbar Bhat, Javid Ahmad Mir and Mukhtar Ahmad Waza have also strongly condemned the government decision, accusing New Delhi of systematically destroying the ecology and environment of Kashmir.

Kin of deceased woman block Sgr-Leh highway

Ganderbal, Aug 1: The relatives and neighbours of a deceased lady blocked Srinagar-Leh highway at Preng here on Friday afternoon, demanding arrest of husband of the deceased who, they alleged, had forced her to take poison.

The protestors alleged that Rukhsana Bano wife of Parvez Ahmad of Chatergul Kangan was forced to take poison by her husband.

"Her husband always used to torture Rukhsana, forcing her to take extreme step," the protesters said. "How was her husband released when investigation process has not been completed," they asked. Rukhsa died in SKIMS after consuming poison at her house last week.

Police said they had already registered a case under FIR No. 65/2014 under section 309 RPC and taken up the investigation.

Sources added that the girl (name withheld) was coaxed and taken to a nearby orchard by Showkat

Reshi where he allegedly raped her. The girl after narrating the incident to her family, approached police station Pattan along with her father where police registered a formal FIR vide No. 180/2014 under section 376, 509, 109 of RPC.
