

All the candidates, whose rank is in the range specified in the counselling schedule, must be present personally in the counselling. They have to produce their Online Admit Card downloaded by them from the BOPEE website, all Original Certificates/Documents as given on pages 24-28 under heading "13. COUNSELLING FOR ALLOTMENT OF DISCIPLINE/INSTITUTION" of CET 2014 Information Brochure, including Marks Card of 10+2, a set of attested copies of these documents, and a non-refundable J&K Bank Draft of Rs. 1000 (Rupees one thousand) drawn in favour of FA/CAO, BOPEE/HDFC Bank Challan of Rs. 1000 (Rupees one thousand). However, the candidates who have joined the discipline/institution allotted to them in the first round of counselling need not to pay the said counselling fees but hall have to produce the proof of their admission (fee receipt of the institution they have joined) and C.N.A. candidates are required to produce their Electronic Admit Card. Candidates who have missed their counselling or admission are also eligible for the final round of counselling provided they pay the additional missed counseling/admission fee of Rs. 1000/= in the form of J&K Bank Draft/HDFC Challan.

The PCM candidates claiming benefit of Tuition Waiver Scheme (TFW) category under category codes 05 & 19 must possess original certificates, with proper office file No. and date, issued by the respective Competent Authorities. The candidates without required original certificates shall not be allowed to participate in the counselling. If a candidate is unable to attend the counselling personally, he/she can be represented by his/her duly authorized representative with Letter of Authority from the candidate as per the format given on page 70 of CET-2014

The latest Seat Matrix will be displayed at BOPEE office, Srinagar and Jammu respectively during the counselling as per the Schedule given above and on BOPEE's websites during the period of counselling. The counselling for allotment of Discipline and Institution shall be held strictly in accordance to the guidelines given in Information Brochure-2014. The allotment of seats shall be made to the candidates on the basis of their merit/rank, choice and availability of seat at the time of counselling.

## Gold up on scattered retail

buying New Delhi, Aug 1: Gold prices inched up by Rs 5 to Rs 28,250 per ten gram in New Delhi on Friday on scattered buying by retailers amid recovery in global prices.

Silver, however, met with resistance and shed Rs 50 to Rs 44,850 per kg.

Traders said apart from buying by retailers for the coming festive season, a better trend in the global market mainly led to rise in gold prices. Globally, gold traded 0.20

per cent higher at \$1,284.91 an ounce in London.

In Delhi, gold of 99.9 and 99.5 per cent purity traded marginally higher by Rs 5 each to Rs 28,250 and Rs 28,050 per ten gram respectively. It had gained Rs 45 on Thursday.
