## INSTRUCTIONS FOR CANDIDATES APPEARING IN ONLINE TEST

- 1. Admission to the examination is strictly provisional. The mere fact that the call letter has been issued to Candidate does not imply that his/her candidature has been accepted by the Bank or that the entries made by Candidate in his/her on-line application for examination have been accepted by the Bank as true and correct. Candidate may please note that the Bank will take up the verification of eligibility conditions i.e. age, educational qualifications, experience and status (i.e. Scheduled Castes/Scheduled Tribes/Other Backward Class/Physically Challenged etc.) with reference to original documents only at the time of interview of candidates who are qualified in the examination on the basis of the marks obtained by them. Candidate may therefore, please note that if at any stage, it is found that Candidate do not satisfy the eligibility criteria as given in the Bank's advertisement, or the information furnished by Candidate in the application is incorrect, his/her candidature is liable to be cancelled forthwith, with such further action as the Bank would like to take.
- 2. Candidate must bring the call letter alongwith the photo identity proof (such as Passport/PAN Card/Driving License/Voter's Card/Bank Passbook with duly attested photograph/Identity Card issued by College or Institute/Identity Card issued by Gazetted Officer in the official letterhead in original/ Unique Identification Card (Aadhar) in original as well as a photocopy. Please note that his/her name as appearing on the call letter (provided by Candidate during the process of registration) should exactly match the name as appearing on the photo identity proof. Female candidates who have changed first/last/middle name post marriage must take special note of this. If there is any mismatch between the name indicated in the Call Letter and Photo Identity Proof Candidate will not be allowed to appear for the exam. The photocopy of photo identity proof should be submitted along with the call letter, to the invigilators in the examination hall failing which he/she will not be permitted to appear for the test.
- 3. Candidate should ascertain exact location of the venue well in advance of the date of examination. The candidates must reach the venue of examination by the time mentioned above. Please note that the candidate reporting 30 minutes after the reporting time will not be allowed in the examination hall nor shall a candidate be permitted to leave the examination hall till the time for the test is over and the test administrator has given permission to leave. The test will begin after completion of the formalities like checking of attendance, obtaining signature on the call letter and collection of call letters alongwith photo identity proof etc. The Bank will not be responsible for any delay or disruption in transport.
- 4. Candidate should also bring a ball point pen with Candidate to the examination hall.
- 5. Candidate will have to affix his/her signature and left thumb impression, in the space provided, in the presence of the Invigilator.
- 6. Biometric data (left thumb impression) will be captured at the test venue. With regards to the same, please note:
  - (a) Fingers should not be coated with stamped ink/mehndi/coloured etc so as to obtain correct biometric impression.
  - (b) If fingers are dirty or dusty, ensure to wash and dry them before the finger print (biometric) is captured.
  - (c) Ensure fingers of both hands are dry. If fingers are moist, wipe each finger to dry them.
  - (d) If the primary finger (left thumb) to be captured is injured/damaged, immediately notify the concerned authority in the test centre. (Any failure to observe these points will result in non-admittance for the test)
- 7. Following items are not allowed inside the examination centre:-
  - Any stationary item like textual material (printed or written), bits of papers, Geometry/Pencil Box, Plastic Pouch, Calculator, Scale, Writing Pad, Pen Drives, Log Table, Electronic Pen/Scanner, Any communication device like Mobile Phone, Bluetooth, Earphones, Microphone, Pager, Health Band etc. Other items like Wallet, Goggles, Handbags, Hair-pin, Hair-band, Belt, Cap, Any watch/Wrist Watch, Camera, Any metallic item, Any eatable item opened or packed, water bottle, Any other item which could be used for unfair means for hiding communication devices like camera, blue tooth devices etc.
  - All ornament like Ring, Earrings, Nose-pin, Chain/Necklace, Pendants, Badge, brooch etc. will be thoroughly checked.
- 8. Following dress code has been advised to the candidates
  - Candidates are wearing light cloths which cannot be used for hiding any instruments or communication devices.
  - Candidates are advised to wear half sleeves but not having big buttons or any badge, brooches etc. which could be used to hide the
    communication device, blue tooth, camera, etc.
  - Candidates are wearing slippers, sandals and not the shoes.
  - However, candidates coming in customary/ religious dresses should report at the centre at least 10 minute prior to reporting time for proper frisking.
- 9. Candidate are advised in his/her own interest not to bring any of the banned items including cell phones to the examination venue, as arrangement for their safekeeping cannot be assured. If Candidate are found resorting to any unfair means including giving/receiving help to/from any candidate during the test Candidate will be disqualified. (The Candidate should be vigilant to ensure that no other candidate is able to copy from his/her answers).
- 10. Please note that if Candidate adopt any unfair means or malpractice or commit any misconduct while appearing for the examination, his/her candidature is liable to be summarily cancelled; moreover Candidate may be liable to penal action. The Bank would be analyzing the responses of a candidate with other appeared candidates to detect patterns of similarity. On the basis of such an analysis, if it is found that the responses have been shared and scores obtained are not genuine/valid, the Bank reserves the right to cancel his/her candidature.
- 11. Candidate should strictly comply with the directions given to Candidate by the test administrator/invigilator. If any candidate is found disregarding these directions he/she will be liable to be debarred from the test.
- 12. Anyone found to be disclosing, publishing reproducing, transmitting, storing or facilitating transmission and storage of test contents in any form or any information therein in whole or part thereof or by any means verbal or written, electronic or mechanical or taking away the papers supplied in the examination hall or found to be in unauthoirsed possession of test content is likely to be prosecuted.
- 13. Please note that a candidate is allowed to appear only once for the examination. <u>Multiple appearances will result in cancellation of candidature</u>. In case more than one call letter has been generated, Candidate are advised to appear for only against the last successful registration on the date and at the time mentioned on the respective call letter. All other call letters are to be surrendered.
- 14. An Acquaint Yourself booklet giving information about the type of test Candidate will be taking is available on the Bank's website. Please download the booklet and study it carefully.
